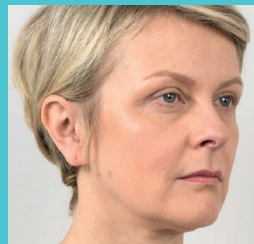

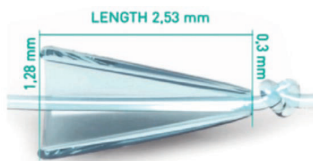

3D cone technology for an effective tissue repositioning

- Hollow cones with large 3D surface provide an efficient soft tissue suspension

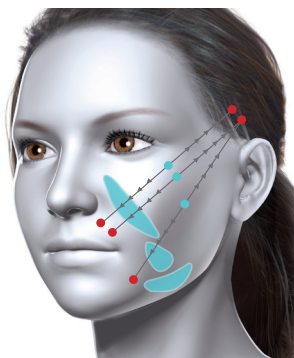
- Use the appropriate number of sutures to maximize your results

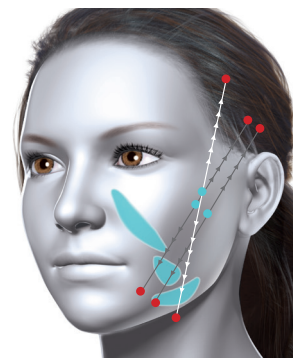

- Mild tissue sagging of the mid-face
- Volume loss in the cheek area leading to the nasolabial folds and labial commissures appearance.

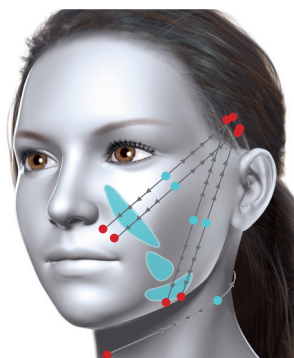

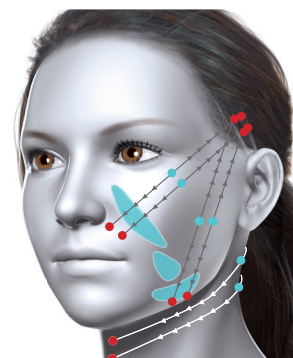

Indications:

- Moderate tissue sagging of the face and neck
- Age-related changes affecting the facial shape and contours, as well as neck contours.

Silhouette Soft is a resorbable sterile implantable single-use device intended for adult patients and is used in multiple pairs to provide for elevation and compression of facial and neck tissue.
